#### **Clinton Township Man Arrested For Felonious Assault**

On Saturday (08-01-15), at approximately 4:30pm, Macomb Sheriff deputies were sent to an address on Jones Street in the City of Mt Clemens for a "man shooting a gun" report.

The caller reported three-to-five gunshots.

Sheriff Deputies went to the address and found it to be a vacant home. The original caller had left the residence prior to the arrival of the deputies.

The deputies went to an adjacent address and talked to three persons there who related that they had heard the gunshots, but they were otherwise uncooperative and they refused to give the sheriff deputies their names.

Eventually, the homeowner (who initially called) returned to the Jones Street address. She told deputies that she was standing in front of 117 Jones Street when she saw a light-colored Ford Contour parked in the middle of the street. She states that the car drove away, but about five minutes later, she saw two males walking towards her, one was dressed all in red, and he had a black gun in his hand.

She told the deputy that words were exchanged before the subject fired three-to-five rounds from the handgun "at her direction". The woman stated that her 12 year old daughter was with her at the time and she was afraid for her life and that of her daughter.

Meanwhile, another deputy located the Ford Contour on N. Walnut near Jones Street, also in the City of Mt. Clemens. The vehicle was unoccupied and as the deputy began to impound it, the vehicle owner returned. He was dressed all in red, and the victim was subsequently able to identify him as the shooter.

The vehicle was impounded, the man was arrested and brought to the Macomb County Jail on charges of Assault w/Intent to Murder.

The gun was not located.

Arrested: Devante Kyran Jennings, 22 years of age and from Clinton Township.

On Monday (08-03) Jennings was arraigned in the 41B District Court of Clinton Township. He was given a \$100,000 cash-or-surety bond and he is due back in Court on 08-17-15 @ 8:30am.

He remains in the Macomb County Jail.

Assault w/Intent to Murder is a felony and carries a potential "life" term.
