##### **Assist Harrison Township Fire Department (AOD)**

On 1-10-15, at approximately 6:30pm, the Macomb County Sheriff's Office received a report of a four-wheeler that had broken thru thin ice. Deputies arrived at an address in the 38000 block of Venetian and learned that a 34 year old Harrison Twp man had been riding his ATV on a frozen canal when it broke thru the ice. The man had his 7 year old daughter on the back of the machine at the time and she managed to make it to the seawall without going in the water. With the help of neighbors, the rider/driver was able to climb out of the water. He incurred a shoulder injury and was subsequently transported to a local hospital for treatment.

The machine will need to be salvaged from the canal at its owner's expense.

##### **Breaking & Entering 01-11-15 3:35am**

Macomb Sheriff Deputies were dispatched to USA Smokers on 21 Mile Road for a commercial burglar-alarm activation. Upon arriving at the location, deputies found the front glass door of the business had been breeched by the use of a prying tool. The security gate was then pried upward to provide access to the inside of the store.

Once the owners of the store arrived, they determined that approximately 180 cartons of Kool and Newport cigarettes were taken in the robbery. Deputies were able to retrieve video-recorded evidence which showed that two subjects had been inside the building.

Macomb Sheriff Deputies were dispatched to a commercial burglar-alarm activation, this one at Wild Bill's Tobacco Store located in the 46000 block of Romeo Plank (also in Macomb Township). Deputies found the front door of the business pried open. Taken were cigarettes, hookah pipes and cash. In reviewing the in-store security system (video-tape), deputies were able to ascertain that there were at least four subjects and that they were driving an "older" white Ford Explorer and a black Chrysler sedan.
