### **Macomb Township Man Charged With Second Degree Murder & Felony Firearm**

Macomb County Sheriff Anthony Wickersham reports that on 02-16-15 at 9am, the Sheriff's Dispatch Center received several 911 calls reporting shots-fired at 45856 Lone Pine Drive in Macomb Township. Deputies arrived to find a 31 year old male deceased in the driveway of the home.

A 76 year-old resident of the home was standing near the deceased and he was taken into custody. Deputies recovered a Smith & Wesson, 9mm handgun that was registered (to the 76 year-old homeowner) from a snow-bank in front of the house.

The victim is identified as Bondaryl McCall age 31 of Pontiac, Michigan (it was previously reported that the victim resided in Detroit, he recently moved to Pontiac). Mr. McCall is the father of three children that resided at the Lone Pine address with their mother, (Mr. McCall's ex-girlfriend).

The arrested man is the great-grandfather of the children and the homeowner at the Lone Pine address: Donald Clayton Miller.

Miller exited the home when McCall arrived and he was armed with his 9mm handgun in a holster. The two men were speaking to each other and at some point, multiple gunshots were heard. Mr. McCall was struck by the gunshots and died at the scene.

Investigators were able to determine that Mr. Miller fired six shots from his handgun striking McCall in the back and the back of his head.

Today, (02-17-15), the Macomb County Prosecutor's Office charged Mr. Miller with:

Count #1: Murder - Second Degree

Count #2: Felony Firearms.

Donald Miller was arraigned in the 41A District Court of Shelby Township and given a \$250,000 cash-or-surety bond.

His next Court date is 03-03-15 in the same Court.

Investigators are still working on a possible motive that caused yesterday's tragic event.
