#### **Detroit Men Arrested for Stealing Car**

On 02-22-2015 at approximately 1:50am, Macomb Sheriff Deputies were dispatched to the San Remo Apartments on Union Lake in Harrison Township for a suspected auto theft "in progress."

The caller told Sheriff Dispatchers that his black 2007 Chevy Trailblazer had just been stolen from the parking lot of his apartment building, and it was now headed southbound on Union Lake towards Shook Road. The Trailblazer was being closely followed by a Dodge Avenger.

The two vehicles first entered the I-94 Freeway travelling eastbound, then once they got to Hall Rd, the two drivers flipped around and began to go westbound on I-94. They were spotted by a Chesterfield Township Police Officer who then radioed Sheriff's deputies.

Sheriff marked patrol vehicles intercepted the stolen Trailblazer and the Avenger on westbound I-94 near North River Road.

When sheriff deputies activated their emergency equipment (lights & sirens), the Avenger pulled over; however the driver of the Trailblazer accelerated to a speed in excess of 100 mph. As the vehicle continued westbound on I-94 and crossed over 14 Mile Road, the driver lost control of the vehicle. The Trailblazer left the roadway, struck a large snow-bank and overturned. It came to rest against the median wall.

The driver of the vehicle was ejected and was found lying in the middle lane of westbound I-94. He was alert and speaking to deputies.

The Avenger and the stolen Trailblazer were being driven by brothers, Jerome Jerell Havard (23) and Jermaine Jormel Havard (25). Both men are from Detroit.

Jerome Havard was transported by ambulance to a local hospital for treatment of injuries he sustained in the roll-over crash.

Jermaine Havard was arrested and transported to the Macomb County Jail.

Jerome Jerell Havard is charged with:

- Count #1: Motor Vehicle – Unlawful Driving Away (5 year felony)
- Count #2: Conspiracy to Commit – Motor Vehicle – Unlawful Driving Away
- Count #3: Police Officer – Fleeing (Second Degree)
- Count #4: Drove While License Suspended

Jerome Havard remains in a local hospital. He has not yet been arraigned on these charges.

Jermaine Jormel Havard has been charged with:

- Count #1: Motor Vehicle – Unlawful Driving Away (5 year felony)
- Count #2: Conspiracy to Commit – Motor Vehicle – Unlawful Driving Away
- Count #3: Drove While License Suspended

At 2pm on Monday (02-23-15), he was video-arraigned in the 41B District Court of Clinton Township. He was given a \$15,000 cash-or-surety bond. His next court appearance is scheduled for 03-09-15 at 8:30am.

He remains in the Macomb County Jail.
