#### UPDATE On Harrison Township Fatality

**MT. CLEMENS, MI – June 29, 2015 – The driver of a Ford van has been charged for Operating While Intoxicated for a December (2014) crash that took the life of a Windsor man.**

On 12-11-14 the Macomb County Sheriff Office investigated an injury-crash that had occurred on North River Road near Interstate 94 in Harrison Township.

According to preliminary reports, a 35 year-old Harrison Township man was driving a silver, 2006 Ford Econoline van, and he was travelling eastbound on North River Rd at approximately 2:42pm.

The driver of the van veered into the westbound lane and struck another van, this one a white, 2008 Ford E250.

The white van, which had been travelling westbound (prior to the crash) was occupied by two persons, a 65 year old man, and a 64 year old woman, both from Windsor, Ontario Canada.

Upon the arrival of Sheriff Deputies, the driver of the silver van was outside his vehicle and alert and talking. The two persons in the other van were pinned inside and rescue personnel had to extricate the couple. The two were transported to McLaren Hospital for treatment of their injuries.

Deputies were subsequently able to determine that the driver of the silver van had an "administratively revoked" driving privilege. Sheriff deputies brought the man to a local hospital and a search warrant was prepared to test his blood.

The man was released at the hospital to be medically treated for injuries sustained in the crash.

On Sunday (12-14-14) at 5:45am, the driver of the white van, John McKee died as a result of his injuries.

**The Macomb County Prosecutor's Office has issued a four-count felony warrant for the driver of the 2006 Ford Econoline Van.**

**On Monday, 06-29-15, David Scott McKinney turned himself in to the Macomb County Sheriff's Office. He was video-arraigned in the 41B District Court of Clinton Township.**

**He is charged with:**

- Count #1: Operating While Intoxicated Causing Death (15 year felony)**
- Count #2: Operating While License Suspended Causing Death (15 year felony)**
- Count #3: Operating While Intoxicated Causing Serious Injury (5 year felony)**
- Count #4: Operating While License Suspended Causing Serious Injury (5 year felony)**

**He was given a \$25,000 cash-or-surety bond.**

**He is due back in Court on 07-13-15.**
