HARRISON TOWNSHIP

Deputies were dispatched to an apartment located on the 35000 block of Jefferson on a report of a Domestic Violence Assault. Once there, deputies learned that a verbal argument between a man and a woman (boy-friend/girlfriend) escalated to a physical altercation wherein the man punched the woman several times in the head. The man was arrested and brought to the Macomb County Jail where he awaits formal arraignment.

The man has two prior convictions for Domestic Violence Assault (#58039-15)

The Macomb Sheriff Dispatch Center received several complaints of a female on dancing on the bow of a boat (in Lake Saint Clair near the Clinton River) and exposing herself. Deputies located the boat and witnessed this behavior. The woman was removed from the boat (at the boat owner's request), she was cited for "indecent exposure" and released from the scene. LENOX TOWNSHIP

A Macomb Sheriff Deputy on patrol near 26 Mile Road and Scheuer Road effected a traffic stop on a vehicle. The driver fled the stopped vehicle (on foot) and the deputy pursued. A taser was deployed and this slowed the subject, however he managed to elude capture. Deputies were able to identify the subject however, and he is a parole absconder (original charge: Bank Robbery). A search of his abandoned vehicle uncovered crack cocaine. This investigation continues. (#58180-15)

MACOMB TOWNSHIP

On 09-05, Deputies were dispatched to an address located in the 46000 block of Meadow Lane on the report of a domestic violence assault. Deputies met with the complainant who states that she and her son were engaged in a verbal argument which escalated to the point where he pushed her hard enough to make her fall into a table and onto the floor. The son fled the residence before the arrival of deputies however he was located and arrested. He was transported to the Macomb County Jail where he awaits formal arraignment (#58176-15).

Deputies were dispatched a gas station on Hall Road in Macomb Township for a report of a suspicious person. Deputies located the man and found him to be in possession of a pill bottle containing approximately 40 (Schedule 3 & 4) pills as well as marijuana. He was transported to the Macomb County Jail where he is awaiting formal arraignment (#58157-15).

Update on Shooting: Macomb Sheriff Anthony Wickersham relates that his deputies and detectives continue to investigate a shooting that occurred Sunday evening (09-06-15) in the parking lot of Tina's County House (50828 North Ave). The shooting occurred at 6:47pm, and the victim, a 20 year old Detroit man remains in a local hospital with non-life threatening injuries.

MT CLEMENS

Macomb Sheriff Deputies were dispatched to an address on Gallup Street in Mt. Clemens on a report of a deceased person. The incident was reported by a neighbor and deputies discovered a 57 year old man deceased in the backyard of a residence. The body was turned over to the Medical Examiner's Office and the decedent's name is not being released pending the notification of next-of-kin. Foul play in not suspected.

WASHINGTON TOWNSHIP

Deputies were dispatched to an address in the 11000 block of Milford Lane for a report of Domestic Violence. Upon arriving, deputies learned that there had been a verbal argument (between a boyfriend and girlfriend) that escalated and
